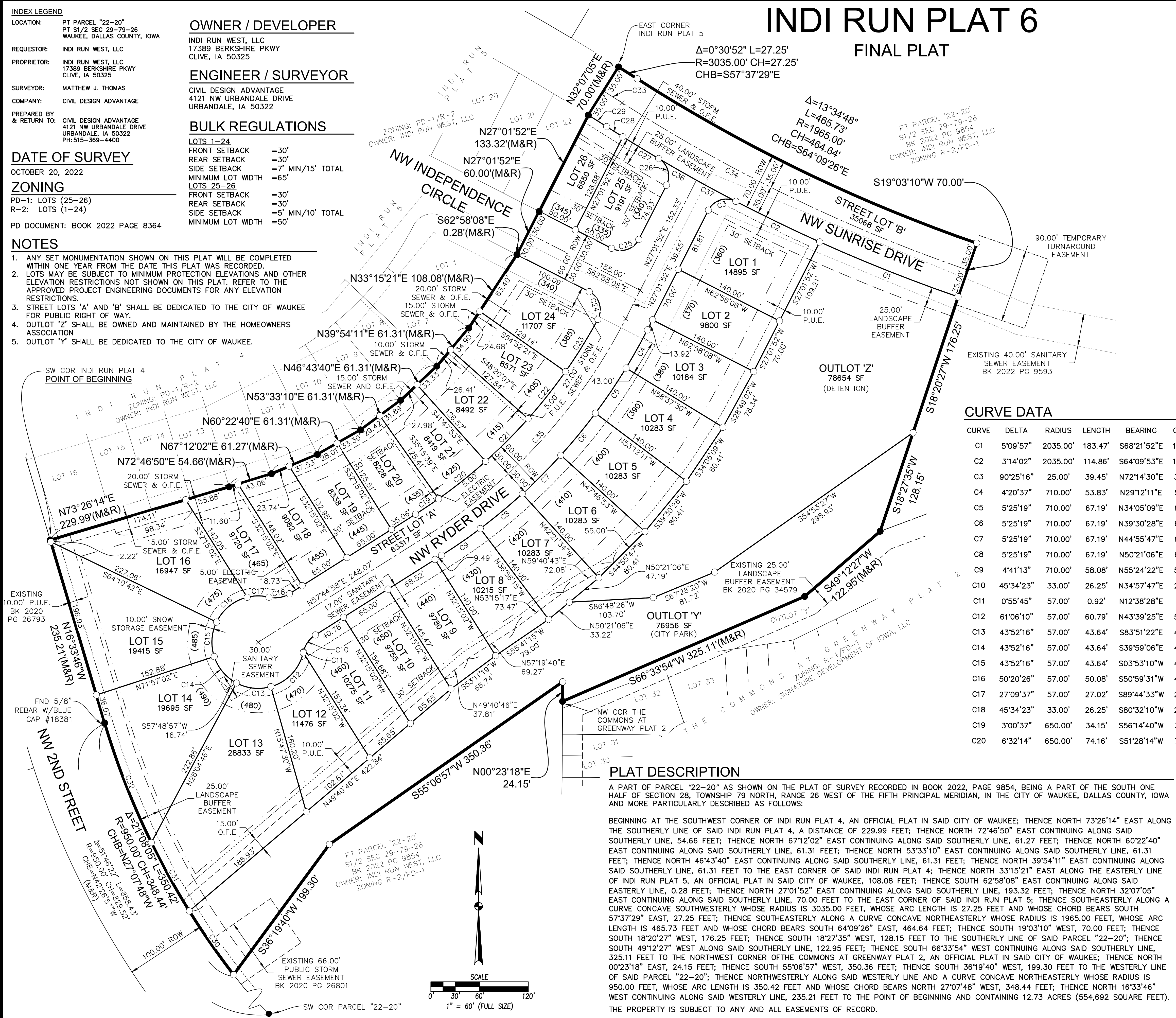

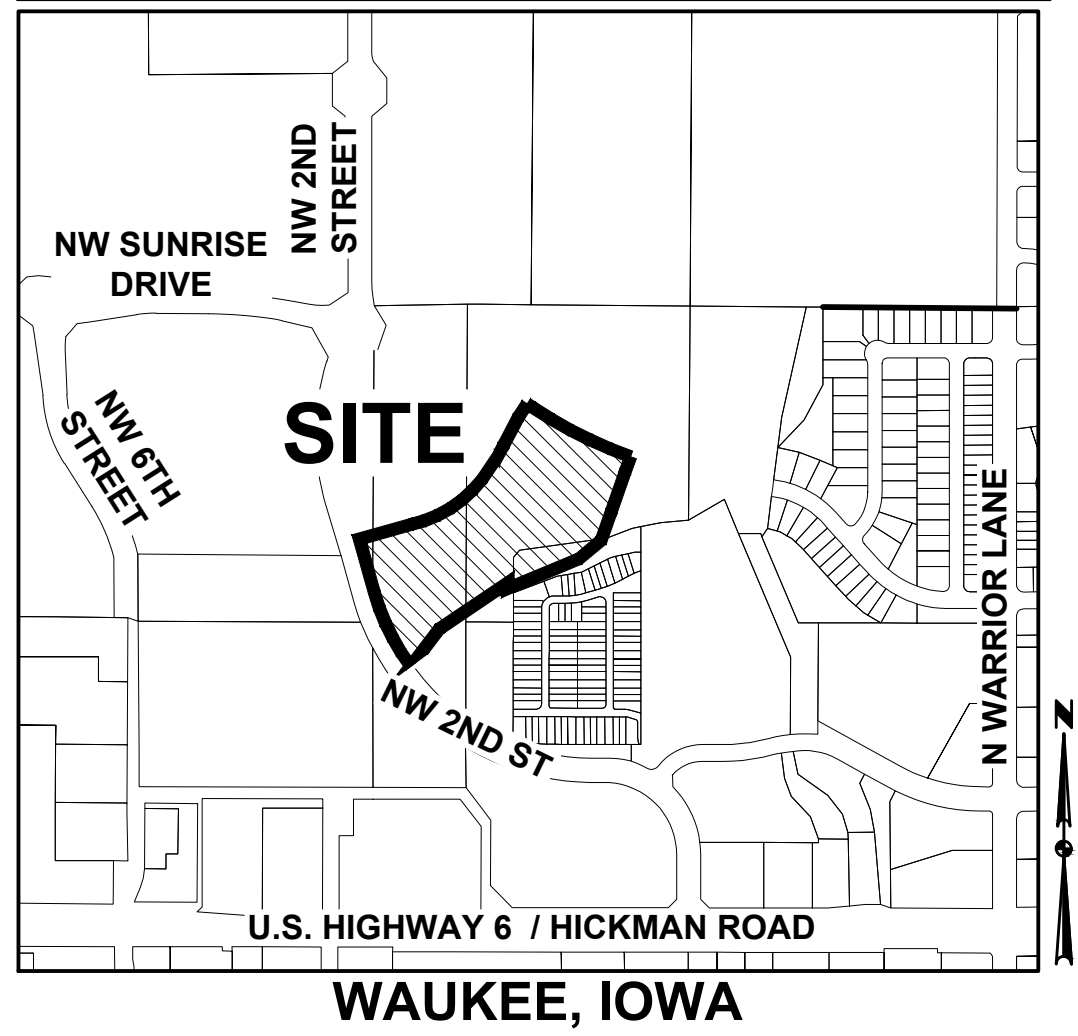

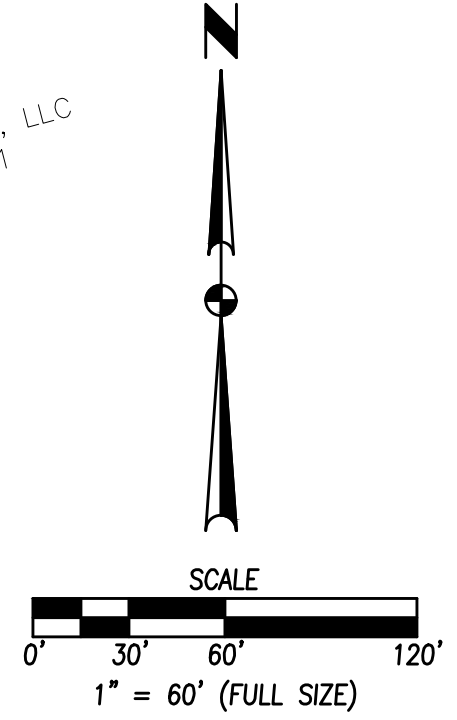

A PART OF PARCEL "22-20" AS SHOWN ON THE PLAT OF SURVEY RECORDED IN BOOK 2022, PAGE 9854, BEING A PART OF THE SOUTH ONE HALF OF SECTION 28, TOWNSHIP 79 NORTH, RANGE 26 WEST OF THE FIFTH PRINCIPAL MERIDIAN, IN THE CITY OF WAUKEE, DALLAS COUNTY, IOWA AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHWEST CORNER OF INDI RUN PLAT 4, AN OFFICIAL PLAT IN SAID CITY OF WAUKEE; THENCE NORTH 73°26'14" EAST ALONG THE SOUTHERLY LINE OF SAID INDI RUN PLAT 4, A DISTANCE OF 229.99 FEET; THENCE NORTH 72°46'50" EAST CONTINUING ALONG SAID SOUTHERLY LINE, 54.66 FEET; THENCE NORTH 67°12'02" EAST CONTINUING ALONG SAID SOUTHERLY LINE, 61.27 FEET; THENCE NORTH 60°22'40" EAST CONTINUING ALONG SAID SOUTHERLY LINE, 61.31 FEET; THENCE NORTH 53°33'10" EAST CONTINUING ALONG SAID SOUTHERLY LINE, 61.31 FEET; THENCE NORTH 46°43'40" EAST CONTINUING ALONG SAID SOUTHERLY LINE, 61.31 FEET; THENCE NORTH 39°54'11" EAST CONTINUING ALONG SAID SOUTHERLY LINE, 61.31 FEET TO THE EAST CORNER OF SAID INDI RUN PLAT 4; THENCE NORTH 33°15'21" EAST ALONG THE EASTERLY LINE OF INDI RUN PLAT 5, AN OFFICIAL PLAT IN SAID CITY OF WAUKEE, 108.08 FEET; THENCE SOUTH 62°58'08" EAST CONTINUING ALONG SAID EASTERLY LINE, 0.28 FEET; THENCE NORTH 27°01'52" EAST CONTINUING ALONG SAID SOUTHERLY LINE, 193.32 FEET; THENCE NORTH 32°07'05" EAST CONTINUING ALONG SAID SOUTHERLY LINE, 70.00 FEET TO THE EAST CORNER OF SAID INDI RUN PLAT 5; THENCE SOUTHEASTERLY ALONG A CURVE CONCAVE SOUTHWESTERLY WHOSE RADIUS IS 3035.00 FEET, WHOSE ARC LENGTH IS 27.25 FEET AND WHOSE CHORD BEARS SOUTH 57°37'29" EAST, 27.25 FEET; THENCE SOUTHEASTERLY ALONG A CURVE CONCAVE NORTHEASTERLY WHOSE RADIUS IS 1965.00 FEET, WHOSE ARC LENGTH IS 465.73 FEET AND WHOSE CHORD BEARS SOUTH 64°09'26" EAST, 464.64 FEET; THENCE SOUTH 19°03'10" WEST, 70.00 FEET; THENCE SOUTH 18°20'27" WEST, 128.15 FEET; THENCE SOUTH 18°27'35" WEST, 128.15 FEET TO THE SOUTHERLY LINE OF SAID PARCEL "22-20"; THENCE SOUTH 49°12'27" WEST ALONG SAID SOUTHERLY LINE, 122.95 FEET; THENCE SOUTH 66°33'54" WEST CONTINUING ALONG SAID SOUTHERLY LINE, 325.11 FEET TO THE NORTHWEST CORNER OF THE COMMONS AT GREENWAY PLAT 2, AN OFFICIAL PLAT IN SAID CITY OF WAUKEE; THENCE NORTH 00°23'18" EAST, 24.15 FEET; THENCE SOUTH 55°06'57" WEST, 350.36 FEET; THENCE SOUTH 36°19'40" WEST, 199.30 FEET TO THE WESTERLY LINE OF SAID PARCEL "22-20"; THENCE NORTHWESTERLY ALONG SAID WESTERLY LINE AND A CURVE CONCAVE NORTHEASTERLY WHOSE RADIUS IS 950.00 FEET, WHOSE ARC LENGTH IS 350.42 FEET AND WHOSE CHORD BEARS NORTH 27°07'48" WEST, 348.44 FEET; THENCE NORTH 16°33'46" WEST CONTINUING ALONG SAID WESTERLY LINE, 235.21 FEET TO THE POINT OF BEGINNING AND CONTAINING 12.73 ACRES (554,692 SQUARE FEET).
